The initial publication contract was with JAI, which published volumes 1 to 7. After JAI shut down in the later 1990s, Volumes 8, 9, and 10 were printed by presses which JAI had found to fulfill its contractual obligations to ASR. In 2004, ASR entered into a new contract with Brill to continue publishing the series, under the General Editorship of William H. Swatos, Jr.
