THEME:

Religion can be a source of both repression and liberation. Some political and religious leaders use religion to control people; others use it to free people from both objective and subjective chains. Religious organizations can collaborate with repressive forces, or they can oppose them in the name of justice. Individuals can use religion to defend systems and structures that harm people, or they can use religion to repair that harm and even prevent it. How and when each happens depends on cultural, social, and economic factors, on social definitions, and also on the religious resources available at the time. Mapping and understanding these dynamics is urgent and vital.

WELCOME FROM THE PRESIDENT

Welcome to the 2022 ASR Annual Meeting! We last met in New York, in 2019, for a very fine meeting under the leadership of Paula Nesbitt, our then-President. In 2020, COVID intervened, and we had to cancel our conference. Last year we held an online meeting, led by our now past-President, Jim Cavendish. This year, we are meeting in-person in Los Angeles, though several dozen people will be Zooming in from various parts of the world. It will be great to be (mostly) back together again.

Our Program Committee, led by Rebecca Catto, has put together a fine program under the theme "Religion, Repression, and the Search for Justice". We have 49 sessions on topics ranging from "Guns, God, and Authoritarianism" to "Catholicism's Crossroads," LGBT+ concerns, multi-racial congregations, and a



panel discussion on "Abortion, Morality, and Ambiguity". Several sessions address methodological concerns. Many sessions report on religion in other parts of the world.

In fact, our international cohort is larger than ever. Over a quarter of our presentations are by scholars based outside the U.S.—a number that would have been higher, had several presenters not been hampered by travel restrictions, visa difficulties, and the like. Fortunately, some of these will be able to present by Zoom, as will some U.S. scholars who also cannot travel.

Two sessions will be available by Zoom to everyone. On Monday morning, we will celebrate the contributions of ASR past-Presidents Roland Robertson (at 8:30) and Jim Beckford (at 10:15), both in Wiltern A. *The Zoom connection is the same for both: Meeting ID: 856 075 1576, Passcode: 451172.*

The ASA Religion Section will join us for two joint sessions: a panel on raising the visibility of our subdiscipline (J5) and a mentoring session for early-career scholars (noon Sunday). The latter gives attendees the choice of such topics as effective writing, publishing, grant seeking, and preparing for various job markets. Many thanks to ASA Section President Kraig Beyerlein for his organizing work.

We have several plenary events, which we hope everyone will attend. They are:


